Applications

Applications for the Brawl will be accepted from September 16, 2019 thru November 1, 2019 only. Any application received after November 1, 2019 will not be accepted. Acts selected on a first come, first serve basis. The first (10) acts to fully complete the application process will compete in Brawl 2019.

How to Enter

Submit entry fee via www.maccschildrensfund.org. Click on the donate button, pay the \$25.00 for your entry fee or, make check or money orders out to MACCS Children's Fund and mail to MACCS Children's Fund, 1400 N. Providence Rd, Bldg. 2, Suite 1020, Media, PA 19063 and send with the completed application.

Prize Redemption

All decisions are final. Prizes must be claimed in person at MACCS Children's Fund, 1400 N. Providence Rd, Bldg. 2, Suite 1020, Media, PA 19063. You will be able to redeem your winnings on or after Monday, November 18, 2019. **Photo ID and completed W-9 are required to collect prize.**

Eligibility

Lip Sync Brawl 2019 is open to anyone 21 years or older at the time of entry.

All acts must pay a \$25.00 entry fee which is separate from the price of the admission ticket. Contest entry fee is non-refundable for confirmed participants.

Sponsor

Participation
